1. This invitation for bids follows the general procurement notice for credit 4954-BD that appeared in UN Development Business, issue no 803 of 31 July, 2011.
2. The People's Republic of Bangladesh has received a credit from International Development Association (IDA) and grants from donors toward the cost of Health, Population and Nutrition Sector Development Program (HPNSDP), and it intends to apply part of the credit and grant proceeds to payments for procurement of BP Blade(surgical), Urine Analysis Strip(Bottle of 100 Strips) and Pregnancy Kit/ Test Kit under the contract Package No. GFP/CC-24/15. Bidding will be governed by the World Bank's eligibility rules and procedures.
3. The Directorate General of Family Planning of the Ministry of Health and Family Welfare now invites sealed bids for Procurement of 4,50,000(Four Lac Fifty thousand)pcs. of BP Blade(surgical), 1,00,000(One Lac)pcs. of Urine Analysis Strip(Bottle of 100 Strips) And 1,45,000(One Lac Forty Five Thousand) pcs. of Pregnancy Kit/ Test Kit through single lot under Contract Package No. GFP/CC-24/15 from eligible and qualified bidders who have manufactured and/or supplied similar goods for five years and specific goods for at least two years and also meet the required qualification requirements described in the Bidding documents. The Delivery Schedules of the goods are as follows:

If there is inordinate delay in opening L/C(i.e. beyond 14 calendar days) after signing of contract, supplier shall be allowed with corresponding increase(i.e. days beyond 14 days) in delivery date.

The Bidder must bid for entire quantity requested in the lot. Bid submitted for less than the entire quantity of the lot will be rejected. Evaluation and comparison of bids will be carried out simultaneously to determine the bid or combination of bids offering the lowest evaluated price to the purchaser.

4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-consulting services under IBRD Loans and

IDA Credits and Grants by World Bank's Borrowers and is open to all eligible bidders as defined in the Procurement Guidelines. However, all countries are eligible for this credit except Israel. A margin of domestic preference will apply.

5. Interested eligible bidders may obtain further information from the office of the Director (Logistics & Supply) and Line Director (Procurement Storage & Supply Management), Directorate General of Family Planning, 6, Kawran Bazar, Dhaka-1215, Bangladesh and inspect the bidding documents at the address given below from **9 Hours Bangladesh Standard Time (BST=GMT+6 hrs.)** to **17 Hours Bangladesh Standard Time (BST=GMT+6 hrs.)** up to **20 March, 2016**.


6. A complete set of bidding documents in English may be purchased by the interested bidders during office hours up to **20 March, 2016** on the submission of a written application to the address below and upon payment of a Non-refundable fee of **BDT 8,000.00 (eight thousand)** only or **US\$ 100.00 (one hundred)** only. The method of payment will be either in Pay Order or in Bank Draft from any schedule bank in Bangladesh or Certified check from reputable foreign bank acceptable to the purchaser. Bidding document may be collected by the bidder or by an authorized representative of interested bidders.

7. Bids must be delivered to the address below at or before **11:00 a.m.** Bangladesh Standard Time (BST=GMT+6 hrs.) on **21 March, 2016**. Electronic bidding will not be permitted. Late Bids will be rejected. Bids will be opened in presence of the bidder representatives who choose to attend in person at the address below at **11:30 a.m.** (BST=GMT+6 hrs.) on **21 March, 2016**.

All bids must be accompanied by Bid Security. **USD 1000.00 (One)** thousand or an equivalent amount in any freely convertible currency(s). The bid security shall be issued by a reputable bank or financial institution. If the bank or institution is located outside of Bangladesh, it shall have a correspondent financial institution located in Bangladesh to make it enforceable.

8. Technical & Financial capability is required to perform the contract (evidence to be submitted). (a) The Bidder should have experience that it has satisfactory completed at least one (1) contract of similar goods of value equivalent an amount of **US\$ 35,000.00 (Thirty five thousand)** or equivalent in any freely convertible currency(ies) under a single contract within the last five years (from the date of submission of bid). (b) The Bidder must have at least two (2) years of experience in manufacturing and marketing of specific goods and five (5) years in similar goods (i.e. years counting backward from the date of bid submission deadline) for which the IFB is issued. (c) The Bidder at the time of bid submission should have at least the amount of liquid asset or working capital or credit facility or their combination for an amount of **US\$ 50,000.00 (Fifty Thousand)** or equivalent in any freely convertible currency(ies). (d) The Purchaser's country does require registration of the goods from the Directorate General of Drug Administration of Bangladesh (DGDA, BD) but for the imported goods the requirement of registration is relaxed at the time of bid submission. However, products offered from oversea(s) manufacturers must be registered with the National Regulatory Authority from the country of origin. The bidder have to submit the DGDA's Registration Certificate or No Objection Certificate prior to contract signing, otherwise the contract will be awarded to the next lowest responsive bidder.

A Pre-bid conference will be held on **18 February, 2016** in Room No 15 (5<sup>th</sup> floor), Logistics & Supply Unit, Directorate General of Family Planning, 6, Kawran bazaar, Dhaka-1215, Bangladesh at **11:30 a.m.**, BST (BST=GMT+6 hours).
