1. This invitation for bids follows the general procurement notice for this project that appeared in Development Business, Issue Nr. 803, dated July 31, 2011.
2. The People's Republic of Bangladesh has received a credit from the International Development Association and grants from donors toward the cost of Health Sector Development Program (HSDP), and it intends to apply part of the proceeds of the credit and grants to payments under the contract for Procurement of Lot-1: 8000 Pcs MR Kits & 2000 Pcs MVA Kits and Lot-2: 8000 Pcs of BP Machine & 8000 Pcs of Stethoscope under contract Package No. GFP/MC- 16/15.
3. The Director (Logistics and Supply) and Line Director (Procurement, Storage and Supply Management), Directorate General of Family Planning of the Ministry of Health and Family Welfare now invites sealed bids from eligible Bidders.
4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits*, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
5. Interested eligible bidders may obtain further information from the Directorate General of Family Planning (DGFP) and inspect the bidding documents at the address given below during working days in between **09.00 a.m. to 05.00 p.m. up to February 20, 2016.**

6. Qualifications requirements include:

A Bidder may bid for one or more lot, but the Bidder must bid for the entire quantity of those item/items in a lot. Lot wise evaluation and comparison of bids will be carried out simultaneously to determine the bid or combination of bids offering the lowest evaluated price to the purchaser. It is noted that Delivery Schedule is in weeks from the opening of Letter of Credit (LC) in case of goods supplied from abroad and from the date of contract Signing in case of the goods supplied from within Bangladesh. Entire quantity of Goods under each lot to be delivered within 08 (Eight) weeks.

• **Qualification requirements for Bidders are:**

(a) Financial Capability

The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):

- The minimum amount of liquid asset or working capital or credit facility is **Tk. 1,40,00,000.00 (Tk. One crore forty lakh) for lot-1 & Tk. 90,00,000.00 (Ninety Lakh) for lot-2.**

(Latest Bank certificate/statement is required and Tenderers participating in more than one lots must have cumulative Liquid Asset for the participating lots).

(b) Experience and Technical Capacity

The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):

- The Bidder shall have a minimum of **five (5)** years of overall experience in the supply of goods and related services. Should have three similar contracts have been executed by them in the past five years.
 - The Bidder shall have successfully completed minimum **one** number supply contract of similar goods (e.g. MR Kits & MVA Kits, BP Machine & Stethoscope, any supply of MSR) and related services within last **five (5)** years. i.e. years counting backward from the date of publication of IFT in the newspaper.
 - The minimum production capacity of Goods is: *The manufacturer should have five times annual production capacity of the offered quantities of the subject items.*
 - The satisfactory completion of supply of similar goods of minimum **Tk. One crore twenty Lakh (1,20,,00,000.00) for lot-1** and Tk. Ninety Lakh (90,00,000.00) for lot -2 under maximum **one (1)** contracts in the last **five (5)** of years. i.e. years counting backward from the date of publication of IFT in the newspaper.


Details qualifications are mentioned in bid document.

A margin of preference for certain goods manufactured domestically "shall" be applied. Additional details are provided in the Bidding Documents.

7. A complete set of bidding documents in English may be purchased by the bidders on submission of a written application to the address below and upon payment of a nonrefundable fee of Taka 8000 (BDT eight thousand) or US\$100 (one hundred). The method of payment will be by Pay Order/Bank Draft. The documents may be collected by the bidder or through an authorized representative.
8. Bids must be delivered to the address below at or before **11:00 a.m. (BST), of February 29, 2016**. All bids must be accompanied by a **bid security (BDT or USD)** follows:
