1. This invitation for bids follows the general procurement notice (GPN) for Credit 4954-BD was published on 31 July, 2011 in issue Nr 803 of the UN Development Business.
2. *The Government People's Republic of Bangladesh has received a credit from the International Development Association (IDA) and grants from donors toward the cost of the Health, Population and Nutrition Sector development Program (HPNSDP), and it intends to apply part of the credit and grant proceeds to payments under the contract for the procurement of low dose oral contraceptive pills. Bidding will be governed by the World Bank's eligibility rules and procedures.*
3. The Director (Logistics and Supply) and Line Director (Procurement, Storage and Supply Management), Directorate General of Family Planning, Ministry of Health and Family Welfare, now invites sealed bids from eligible bidders for procurement of 45 (Forty Five) million cycles Low Dose Oral Contraceptive Pills (LDOP) through 5 (Five) sub packages of 09 (Nine) million cycles each *under contract package No. GFP/FS-01/15.*
4. Bidding will be conducted through the international competitive bidding procedures specified in the World Bank's Guidelines: Procurement of goods, works and non-consulting services under IBRD Loans and IDA Credits and Grants by World Bank Borrowers and is open to all bidders from eligible source countries as defined in the Guide lines. A margin of preference will be granted for the goods manufactured in Bangladesh.
5. Interested eligible bidders may obtain further information from office of Director (Logistics and Supply) and Line Director (Procurement, Storage & Supply Management), Directorate General of Family Planning and inspect the bidding documents at the address given below during working days from **9 Hours Bangladesh Standard Time (BST=GMT+6 hrs.) to 17 Hours Bangladesh Standard Time (BST=GMT+6 hrs.)** up to the day before the deadline for Bid submission i.e. **22 March, 2016.**
6. A complete set of bidding documents in English may be purchased by interested bidders up-to **21 March, 2016** during office hours on submission of a written application to the address below and upon payment of a non-refundable fee of Taka 8000.00 (Taka eight thousand) or US\$ 100.00 (USD One hundred) up to the day before the deadline for Bid submission. The method of payment will be by pay order or bank draft from any scheduled Bank.
7. Bids must be delivered to the address below at or before **11-30 Hours Bangladesh Standard Time (BST=GMT+6 hrs.) on on 22 March, 2016.** Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at **11.55 Hours Bangladesh Standard Time (BST=GMT+6 hrs.) on 22 March, 2016.**

Bid must be accompanied by a bid security of US\$ 20,000 or equivalent for each lot separately. If issued from a foreign Bank, then the security must be endorsed by a scheduled Bank in Bangladesh as authentic. Bidding documents will be delivered from Logistics and Supply Unit, DGFP to the bidders or their authorized representatives

8. Technical & Financial capability is required to perform the contract (evidence to be submitted). (a) The manufacturer should have manufacturing and supply record of LDOP of Offered quantities as per the schedule of requirement within last five years. (b) The bidder has successfully supplied at least 5 million cycles of LDOP in not more than 2 contracts within last five years. (c) The minimum amount of liquid asset or working capital or credit facility is US\$ 80,000 or equivalent in any freely convertible currency(ies) for each lot (d) The Purchaser's country requires registration of Pharmaceuticals from by the Directorate General of Drug Administration (DGDA) of Bangladesh. Products offered from overseas manufacturers must be registered with the National Regulatory Authority from the country of origin and bidder should submit a copy of the Product Registration certificate and a copy of the receipt by the DGDA of the application for registration of the Good(s) along with the bid. The winning bidder is required to obtain DGDA's Registration Certificate or No Objection Certificate (NOC) on the offered product from DGDA prior to signing of the contract, otherwise contract will be awarded to the next lowest responsive bidder

9. A pre-bid conference will be held on 10-02-2016 in the office of the undersigned at 11-30 Hours Bangladesh Standard Time (BST=GMT+6 hrs.). All Bidders (Preferably having product knowledge) are requested to attend the conference in time.
