1. This invitation for bids follows the general procurement notice (GPN) for Credit 4954-BD was published on 31 July, 2011 in issue Nr 803 of the UN Development Business.
2. *The Government People's Republic of Bangladesh has received a credit from the International Development Association (IDA) and grants from donors toward the cost of the Health, Population and Nutrition Sector development Program (HPNSDP), and it intends to apply part of the credit and grant proceeds to payments under the contract for the procurement of Tubectomy Kit, IUD Sterilizer, IUD Insertion kit, Pelvic Model for IUD, Counseling Kit. Bidding will be governed by the World Bank's eligibility rules and procedures.*
3. The Director (Logistics and Supply) and Line Director (Procurement, Storage and Supply Management), Directorate General of Family Planning, Ministry of Health and Family Welfare, now invites sealed bids from eligible bidders for procurement of Lot 1: 6(Six) thousand Tubectomy Kit , Lot 2: 4 (Four) thousand IUD Sterilizer, Lot3: 3 (Three) thousand IUD Insertion kit, Lot 4: 1500 (Fifteen Hundred) pcs of Pelvic Model for IUD. Lot 5: 5 (Five) thousand Counseling Kit *under contract package No. GFP/CC-19/15.*
4. Bidding will be conducted through the international competitive bidding procedures specified in the World Bank's Guidelines: Procurement of goods, works and non-consulting services under IBRD Loans and IDA Credits and Grants by World Bank Borrowers and is open to all bidders from eligible source countries as defined in the Guide lines. A margin of preference will be granted for the goods manufactured in Bangladesh.
5. Interested eligible bidders may obtain further information from office of Director (Logistics and Supply) and Line Director (Procurement, Storage & Supply Management), Directorate General of Family Planning and inspect the bidding documents at the address given below during working days from **9 Hours Bangladesh Standard Time (BST=GMT+6 hrs.)** to **17 Hours Bangladesh Standard Time (BST=GMT+6 hrs.)** up to the day before the deadline for Bid submission i.e. **22 March, 2016.**
6. A complete set of bidding documents in English may be purchased by interested bidders up-to **21 March, 2016** during office hours on submission of a written application to the address below and upon payment of a non-refundable fee of Taka 8000.00 (Taka eight thousand) or US\$ 100.00 (USD One hundred) up to the day before the deadline for Bid submission. The method of payment will be by pay order or bank draft from any scheduled Bank.
7. Bids must be delivered to the address below at or before 11-30 Hours Bangladesh Standard Time (BST=GMT+6 hrs.) on **22 March, 2016.** Electronic bidding will not be permitted. Late bids will be rejected.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 11.45 Hours Bangladesh Standard Time (BST=GMT+6 hrs.) on **22 March, 2016**.

All bids must be accompanied by Bid a bid security of USD 3,400 (three thousand and four thousand) or BDT 2,65,000 (Taka Two lakh and Sixty Five thousand) for lot 1; USD 6,500 (Six thousand and Five hundred) or BDT 5,20,000 (Taka Five lakh and Twenty thousand) for Lot 2; USD 1,600 (One thousand and Six Hundred) or BDT 1,24,000 (Taka One lakh and Twenty Four thousand) for Lot 3; USD 1,600 (One thousand and Six Hundred) or BDT 1,24,000 (Taka One lakh and Twenty Four thousand) for Lot 4 and USD 2,500 (Two thousand and five hundred) or BDT 2,00,000 (Taka Two lakh) for lot 5. Bidders participating in multiple Lots shall submit bid security for each Lot separately. If issued from a foreign Bank, then the security must be endorsed by a scheduled Bank in Bangladesh as authentic. Bidding documents will be delivered from Logistics and Supply Unit, DGFP to the bidders or their authorized representatives

8. Technical & Financial capability is required to perform the contract (evidence to be submitted). (a) The Bidder at the time of bid submission should have at least the amount of liquid asset or working capital or credit facility or their combination: For Lot No. 1: US\$ 1,70,000 or equivalent in any freely convertible currency (ies); For Lot No. 2: US\$ 3,30,000 or equivalent in any freely convertible currency (ies); For Lot No. 3: US\$ 75,000 or equivalent in any freely convertible currency (ies); For Lot No. 4: US\$ 75,000 or equivalent in any freely convertible currency (ies); For Lot No. 1: US\$ 1,25,000 or equivalent in any freely convertible currency (ies) (b) Bidder shall demonstrate that it has successfully completed at least 1 (one) contract of similar goods having value mentioned below within the last five years: For Lot No. 1: US\$ 1,70,000 or equivalent in any freely convertible currency (ies); For Lot No. 2: US\$ 3,30,000 or equivalent in any freely convertible currency (ies); For Lot No. 3: US\$ 75,000 or equivalent in any freely convertible currency (ies); For Lot No. 4: US\$ 75,000 or equivalent in any freely convertible currency (ies); For Lot No. 1: US\$ 1,25,000 or equivalent in any freely convertible currency (ies)
