1. This invitation for bids follows the general procurement notice for this project that appeared in UNDP, issue no 803 of 31 July, 2011.

2. The Government of People's Republic of Bangladesh has received a credit from International Development Association (IDA) and grants from donors toward the cost of Health, Population and Nutrition Sector Development Program (HPNSDP), and it intends to apply part of the credit and grant proceeds to payments under the contract for Procurement **Various MSRs under 4 Lots: Lot-1: Autoclave Steam Sterilizer-1954 pcs; Lot-2: Ultrasound Scanner-2 pcs ; Lot-3: Synthetic Absorbable Suture (PGA or Poly Galactin 910 with atraumatic 1-0 round needle)-2,00,000 pcs; Lot-4: a) Surgical Rubber Gloves (6.5")- 14,00,000 pairs & b) Surgical Rubber Gloves (7.0")-6,00,000 pairs** under Contract Package No.GFP/CC-18/15. Bidding will be governed by the World Bank's eligibility rules and procedures.

The Directorate General of Family Planning of the Ministry of Health and Family Welfare now invites sealed bids for Procurement Various MSRs under 4 Lots: Lot -1: Autoclave Steam Sterilizer- 1954 pcs; Lot-2: Ultrasound Scanner-2 pcs ; Lot -3: Synthetic Absorbable Suture (PGA or Poly Galactin 910 with atraumatic 1-0 round needle)-2,00,000 pcs; Lot-4: a) Surgical Rubber Gloves (6.5")- 14,00,000 pairs & b) Surgical Rubber Gloves (7.0")- 6,00,000 pairs under Contract Package No.GFP/CC-18/15 from eligible and qualified bidders who meets the qualification requirements described below:

The Bidder at the time of bid submission should have at least the amount of liquid asset or working capital or credit facility or their combination mentioned below:

- (a) For Lot -1: US\$ **800,000** or equivalent in any freely convertible currency(ies).
- (b) For Lot -2: US\$ **80,000** or equivalent in any freely convertible currency(ies).
- (c) For Lot -3: US\$ **400,000** or equivalent in any freely convertible currency(ies).
- (d) For Lot -4: US\$ **500,000** or equivalent in any freely convertible currency(ies).

Bidders participating in both the lots must have cumulative financial capability for the lots.

The Bidder may bid for one or more lots but the Bidder must bid for entire quantity requested in each lot. Bid submitted for less than the entire quantity of any lot will be rejected. Evaluation and comparison of bids will be carried out simultaneously to determine the bid or combination of bids offering the lowest evaluated price to the purchaser. Price reduction or Cross discounts will be considered in the evaluation and comparison of bids for more than one lot.

4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement of Goods, under IBRD Loans and IDA Credits and Grants by World Bank's Borrowers and is open to all eligible bidders as defined in the Procurement Guidelines. However, all countries are eligible for this credit except Israel. A margin of domestic preference will apply.

5. Interested eligible bidders may obtain further information from the Directorate General of Family Planning (DGFP) and inspect the bidding documents at the address given below during working days in between **09.00 a.m. to 05.00 p.m. up to 13 April 2016**. The bidding document is also available at the DGFP website ([www.dgfpbd.org](http://www.dgfpbd.org)). However, the web version of the document is for information purpose only.

6. A complete set of bidding documents in English may be purchased by the bidders on submission of a written application during office hours up to 13 April, 2016 to the address below and to the Room no. 314, Office of the Joint Secretary (FW), Ministry of Health & Family Welfare, Bangladesh Secretariat, Dhaka 1000 upon payment of a nonrefundable fee of Taka

8000 (BDT eight thousand) or US\$100 (one hundred). The method of payment will be by Pay Order/Bank Draft. The documents may be collected by the bidder or through an authorized representative. For overseas delivery, the bidder may obtain the bidding document by instructing any international courier service to collect the same from the following address.

7. Bids must be delivered to the Room No 314, Office of the Joint Secretary (FW), Ministry of Health & Family Welfare, Bangladesh Secretariat, Dhaka 1000 at or before **2:00** p.m. Bangladesh Standard Time on 17 April, **2016**. Electronic bidding will not be permitted. Late Bids will be rejected. Bids will be opened in presence of the bidder representatives who choose to attend in person at the same address at **2:30** p.m. on 17 April, **2016**.

8. All bids must be accompanied by Bid Security. The bid security should be in the form of a Bank Guarantee in any freely convertible currency from an eligible country as follows:
