1. This invitation for bids follows the general procurement notice for this project that appeared in UNDP, issue no 803 of 31 July, 2011.
2. The Government of the People's Republic of Bangladesh has received a credit from International Development Association (IDA) and grants from donors toward the cost of Health, Population and Nutrition Sector Development Program (HPNSDP), and it intends to apply part of the credit and grant proceeds to payments under the contract for Procurement of **Auto-Disable (AD) Syringe (one ml)** through Four lots 2 (two) million in each under Contract Package No.GFP/FS-03/15. Bidding will be governed by the World Bank's eligibility rules and procedures.
3. The Directorate General of Family Planning of the Ministry of Health and Family Welfare now invites sealed bids for Procurement of Auto-Disable (AD) Syringe (one ml) under Contract Package No.GFP/FS-03/15 from eligible and qualified bidders who have manufactured and/or supplied similar goods for five years and specific goods for at least two years and also meet the required qualification requirements described in the Bidding documents. The Delivery Schedules of the goods are as follows:

4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-consulting services under IBRD Loans and IDA Credits and Grants by World Bank's Borrowers and is open to all eligible bidders as defined in the Procurement Guidelines. However, all countries are eligible for this credit except Israel. A margin of domestic preference will apply.

5. Interested eligible bidders may obtain further information from the office of the Director (Logistics & Supply) and Line Director (Procurement Storage & Supply Management), Directorate General of Family Planning, 6, Kawran Bazar, Dhaka-1215, Bangladesh and inspect the bidding documents at the address given below from **9 Hours Bangladesh Standard Time (BST=GMT+6 hrs.) to 17 Hours Bangladesh Standard Time (BST=GMT+6 hrs.) up to March 15, 2016**. However, for participating in the bid, bidder shall furnish Documentary evidence that it meets the following requirements:

(A) Financial Capability of the bidder:

- (i) Liquid Assets: For each lot, the Bidder at the time of bid submission must have liquid asset or working capital or credit facility or any combination of these of at least US\$ 120,000 or equivalent in any currency.
- (ii) Average Annual Turnover: For each lot, the Bidder must have average annual turnover (sales value) of at least US\$ 300,000.00 or equivalent during the last 03 (Three) years. [Years counting backward from the bid submission deadline]. Bidder will submit audited financial statements in support of the turnover.
Bidders participating in more than one lots must meet cumulative financial requirements for the participating lots.

(B) Experience of the Bidder

(i) General Experience:

The Bidder (in case of JV, each partner) should have at least five (5) years of general experience in supplying pharmaceutical products (i.e. years counting backward from the date of bid submission deadline).


(ii) Specific Experience:

The Bidder shall at-least have experience of supplying AD Syringe having value mentioned below in not more than two contracts, within the last five (5) years (i.e. years counting backward from the date of bid submission deadline):

- (a) For Lot No. 1: US\$120,000 or equivalent in any freely convertible currency(ies) in not more than 2 contracts;
- (b) For Lot No.2: US\$ 120,000 or equivalent in any freely convertible currency(ies) in not more than 2 contracts;
- (c) For Lot No.3: US\$ 120,000 or equivalent in any freely convertible currency(ies) in not more than 2 contracts;
- (d) For Lot No.4: US\$ 120,000 or equivalent in any freely convertible currency(ies) in not more than 2 contracts;

(C) Manufacturer's Capability and Capacity

Manufacturers have documentary evidence having Annual Production Capacity of at least FOUR times of the offered quantities.




6. A complete set of bidding documents in English may be purchased by the interested bidders during office hours up to **March 15, 2016** on the submission of a written application to the address below and upon payment of a Non-refundable fee of BDT 8,000.00 (eight thousand) only or US\$ 100.00 (one hundred) only. The method of payment will be either in Pay Order or in Bank Draft from any schedule bank in Bangladesh or Certified check from reputable foreign bank acceptable to the purchaser. Bidding document may be collected by the bidder or by an authorized representative of interested bidders.

7. Bids must be delivered to the address below at or before **11:00 a.m.** Bangladesh Standard Time (BST=GMT+6 hrs.) on **March 16, 2016**. Electronic bidding will not be permitted. Late Bids will be rejected. Bids will be opened in presence of the bidder representatives who choose to attend in person at the address below at **11:30 a.m.** (BST=GMT+6 hrs.) on **March 16, 2016**.

8. All bids must be accompanied by a Bid Security. The amount of the Bid Security, for each lot, shall be US\$ 3,000.00 or an equivalent amount in any freely convertible currency. The bid security shall be issued by a reputable bank or financial institution. If the bank or institution is located outside of Bangladesh, it shall have a correspondent financial institution located in Bangladesh to make it enforceable.

9. A Pre-bid conference will be held on **February 14, 2016** in Room No.15 (5th floor), Logistics & Supply Unit, Directorate General of Family Planning, 6, Kawran bazaar, Dhaka-1215, Bangladesh at **11:00 AM**, BST(BST=GMT+6 hours). All prospective bidders/bidders' representatives are requested to attend the conference in time.
