**1.** This invitation for bids follows the general procurement notice for this project that appeared in UNDP, issue no 803 of 31 July, 2011.

- 2. The Government of People's Republic of Bangladesh has received a credit from International Development Association (IDA) and grants from donors toward the cost of Health, Population and Nutrition Sector Development Program (HPNSDP), and it intends to apply part of the credit and grant proceeds to payments under the contract for Procurement of 02 (two) pieces of Laparscope with accessories for Tubal ligation and 92 (ninety two) pieces of Portable OT light with Charger through 2 (two) lots under Contract Package No.GFP/CC-29/15. Bidding will be governed by the World Bank's eligibility rules and procedures.
- **3.** The Directorate General of Family Planning of the Ministry of Health and Family Welfare now invites sealed bids for Procurement of 02 (two) pieces of Laparscope with accessories for Tubal ligation and 92 (ninety two) pieces of Portable OT light with Charger under Contract Package No.GFP/CC-29/15 from eligible and qualified bidders who meets the qualification requirements described below:
- (i) The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):

The Bidder must have average annual turnover (sales value)

**For Lot No. 01**: At least BDT 21.0 (Twenty one) million or equivalent US\$ 262,500 (Two hundred sixty two thousand five hundred).

**For Lot No. 02**: At least BDT 39.0 (Thirty nine) million or equivalent US\$ 487,500.00 (Four hundred eighty seven thousand five hundred).

- (ii) Experience and Technical Capacity
  - (a) **General and Specific Experience**: The Bidder must have at least two (2) years of experience in manufacturing and marketing of specific goods and five (5) years in similar goods (i.e. years counting backward from the date of bid submission deadline) for which the IFB is issued.
  - (b) **Supply Experience**: The Bidder should have experience that it has successfully completed at least one (1) contract of similar goods of value BDT 7.0 (Seven) million or equivalent US\$ 87,500.00 (Eighty seven thousand five hundred) for Lot No. 01 and BDT 13.0 (Thirteen) million or equivalent US\$ 162,500.00 (One

- hundred sixty two thousand five hundred) for Lot No. 02 under a single contract within the last five years (from the date of submission of bid).
- (c) **Annual Production Capacity:** The Bidder should have Annual Production Capacity of at least 4.0 (Four) times the quantities specified for each lot under the contract package.

The Bidder may bid for one or more lots but the Bidder must bid for entire quantity requested in each lot. Bid submitted for less than the entire quantity of any lot will be rejected. Evaluation and comparison of bids will be carried out simultaneously to determine the bid or combination of bids offering the lowest evaluated price to the purchaser. Price reduction or Cross discounts will be considered in the evaluation and comparison of bids for more than one lot.

- **4**. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement of Goods, under IBRD Loans and IDA Credits and Grants by World Bank's Borrowers and is open to all eligible bidders as defined in the Procurement Guidelines. However, all countries are eligible for this credit except Israel. A margin of domestic preference will apply.
- **5.** Interested eligible bidders may obtain further information from the office of the Director (Logistics & Supply) and Line Director (Procurement Storage & Supply Management), Directorate General of Family Planning, 6, Kawran Bazar, Dhaka-1215, Bangladesh and inspect the bidding documents at the address given below from 9 Hours Bangladesh Standard Time (BST=GMT+6 hrs.) to 17 Hours Bangladesh Standard Time (BST=GMT+6 hours).
- **6**. A complete set of bidding documents in English may be purchased by the interested bidders during office hours up to **March 03**, **2016** on the submission of a written application to the address below and upon payment of a Non-refundable fee of BDT 8,000.00 (eight thousand) only or US\$ 100.00 (one hundred) only. The method of payment will be either in Pay Order or in Bank Draft from any schedule bank in Bangladesh or Certified check from reputable foreign bank acceptable to the purchaser. Bidding document may be collected by the bidder or by an authorized representative of interested bidders.
- 7. Bids must be delivered to the address below at or before 11:00 a.m. Bangladesh Standard Time (BST=GMT+6 hrs.) on **March 06, 2016**. Electronic bidding will not be permitted. Late Bids will be rejected. Bids will be opened in presence of the bidder representatives who

choose to attend in person at the address below at 11:30 a.m. (BST=GMT+6 hrs.) on March 06, 2016.

- **8.** All bids must be accompanied byBid Security. The amount of bid security is BDT 120,000.00 (One hundred twenty thousand) or US\$ 1,500.00 (One thousand five hundred) for Lot No. 01 and BDT 240,000.00 (Two hundred forty thousand) or US\$ 3,000.00 (Three thousand) for Lot No. 02. The bid security shall be issued by a reputable bank or financial institution. If the bank or institution is located outside of Bangladesh, it shall have a correspondent financial institution located in Bangladesh to make it enforceable.
- **9**.
