

Subject: Minutes of the Pre-bid meeting held on February 04, 2016 at 11:00 a.m. against IFB No. DGFP/L&S-3/laparscope/2015-16/102/32 dated 21.01.2016 for Procurement of 02 (two) pieces of Laparscope with accessories for Tubal ligation and 92 (ninety two) pieces of Portable OT light with Charger for Clinical Contraception Services Delivery Program under Contract Package No. GFP/CC-29/15.

A pre-bid meeting was held on February 04, 2016 at 11:00 a.m. in Room # 15 (5th Floor), Logistics & Supply Unit, Directorate General of Family Planning, 6, Karwanbazar, Dhaka-1215 for procurement of 02 (two) pieces of Laparscope with accessories for Tubal ligation and 92 (ninety two) pieces of Portable OT light with Charger under Contract Package No. GFP/CC-29/15. Director (Logistics & Supply), Md. Abdus Salam Sarker (Joint Secretary) presided over the meeting. The participants attended in the meeting are shown in Annexure-A & B.

The Chairperson cordially welcomed the participants. At the outset he drew attention of the prospective bidders/representatives that the purchaser is using the World Bank's latest Standard Bidding documents of goods April 2015 for this procurement. As a result the Bidder must use the necessary forms of Section IV of this Bidding documents for bid submission purposes. The Chairperson also said that the purchaser is very much strict on the principal of following the specification and supply experience with a view to have the best utility of public money and ensure the best quality of the procuring objects. He then requested Sabina Parveen, Deputy Director (Foreign Procurement) to present the agenda item of the meeting. Accordingly, Sabina Parveen explained some new clauses included in the latest version and requested all to go through the Bidding documents before submission. She also informed that Bidding documents were ready for sale from January 22, 2016 and up to February 4, 2016; 10 (ten) bidders purchased the Bidding documents.

After these, the chairperson invited prospective Bidders for open discussion on the Bidding documents. The points raised by the representatives of the prospective Bidders are noted down and assured to be given as a clarification through amendment within short time.

On the observations of Technical specifications clarifications were seeking to the user Line Director on February 07, 2016 and the user Line Director given his amendment/clarification on February 10, 2016. As per his opinion the amendment (on written and verbal queries) are attached herewith the minutes.

The Amendment will be a part of the Bidding documents. It was also agreed that no further time is required for Bid submission. However, the delivery time has been extended as per their request from 12 weeks to 14 weeks.

As there were nothing more to discuss, the meeting was ended with a vote of thanks to the members present from the chair.
